

GREEN SHADE TREE REBATE APPLICATION

REBATE TERMS

1. Must be a CPS Energy customer to receive rebate in the form of a credit on utility bill.
2. **Purchase an eligible tree(s) during October 1, 2023 through April 30, 2024.**
3. Tree(s) must be at least a size #5 container (5 gallon) or larger and from the approved species list.
4. Plant tree(s) within 10-30 ft of air-conditioned building.
5. **LIFETIME LIMIT FIVE (5) TREE REBATES FOR A MAXIMUM OF \$250 PER PHYSICAL ADDRESS (NO P.O. BOX).** Customers who previously received less than the 5 rebate total are eligible for rebates to bring the total to 5.
6. Read and follow the required Green Shade Rebate Guidelines (see cpsenergy.com/treerebate).
7. Complete and sign this application, and **SUBMIT WITH A PHOTOCOPY OF ORIGINAL RECEIPT** – showing tree purchase with itemized tree species and size between October 1, 2023 and April 30, 2024; and submit **PHOTOCOPY OF RECENT CPS ENERGY BILL.**
8. **Applications must be postmarked or emailed by May 15, 2024. Rebates are available until funds are exhausted.**

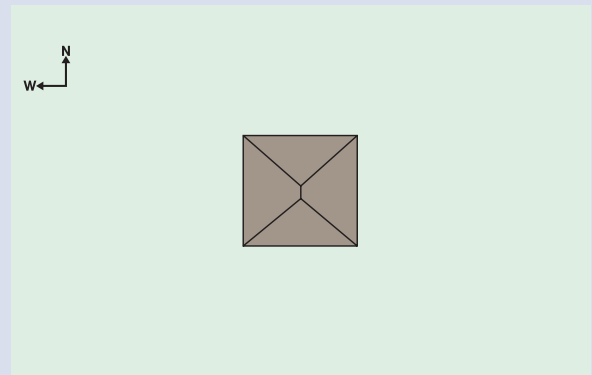
