The meeting was called to order at 11:34 a.m. by Chair John Kelly.

APPROVAL OF MINUTES

Approval for the meeting minutes from September 13, 2023, was motioned by Steve Bonnette and seconded by Bill Day with corrections.

MULTI-YEAR FINANCIAL STRATEGY BRIEFING

Opening remarks were made by CPS Energy President and CEO, Rudy Garza on CPS Energy's Vision 2027 strategy, the community input working group beginning their sessions, and the investments needed to continue the transformation of the utility.

Geronimo Gonzalez, Sr. Director of Budgeting, Analysis & Management Reporting, presented on CPS Energy's multi-year financial strategy. Geronimo provided a historical overview of CPS Energy's growth and investments. Geronimo stated that the investments funded through our last rate request have supported infrastructure resiliency, technology, security, people and growth.

Geronimo mentioned that the details of our multi-year rate plan were being validated and a preliminary recommendation will be presented to the committee next month.

Lastly, Geronimo stated that through the series of public meetings with community input working group, CPS Energy will obtain feedback on specific issues relevant to the utility's 2023 rate journey.

• CPS Energy recognizes the importance of transparency in financial performance and will continue to provide financial updates to supporting committees.

What can customers do and why?

• Customers are encouraged to continue their advocacy for citizen input with their involvement in any of the upcoming CPS Energy events.

What can the CAC do to help?

• Inform CPS Energy customers about CPS Energy's financial need to execute on Vision 2027 and engage with the community.

Yvonne Pelayo noted that Shanna Ramirez, CPS Energy's Chief Legal Officer, General Counsel & Board Secretary, will provide an update at the November 16th CAC meeting.

Various members of the CAC stated concerns on the direction of the CAC committee, and on the mission and vision of the ad hoc committee.

Yvonne Pelayo mentioned that the community input working group's purpose is solely to offer feedback to CPS Energy management regarding the upcoming rate request.

Chair Kelly, at Tom Corser's request, formed a subcommittee to discuss options for the CAC future state. The subcommittee is comprised of CAC members Tom Corser, Lawson Picasso and Diana Martinez.
