INFORMATION ABOUT THE POTRANCO SUBSTATION PROJECT

What is the Potranco Substation project?

CPS Energy plans to construct a new electric substation near the intersection of Potranco Road and Richland Hills in the north west area of San Antonio. This facility will be built on CPS Energy property. The new substation will be supplied from an existing highvoltage transmission line that runs along Potranco Road.

A substation is a local power hub or distribution point for electricity. This substation will provide additional electric capacity to accommodate existing and future growth, and it will improve the reliability of electric services to homes and businesses in the area.

Construction of the substation is tentatively scheduled to begin in the August 2016 and will be completed by summer 2018.

Why is this project needed?

Potranco Substation is needed to serve a growing area that is served by long circuits from Hunt Lane, Southwest Research, and Grissom substations. The new substation will provide additional capacity in the area and avoid overload conditions from existing substations. In addition, the new substation will improve the reliability of the area with shorter circuits, strong backbone routes, and sufficient ties.

How might this affect you?

The location of the new substation will not impact private property. Potranco Substation will be built on CPS Energy property, and there is an existing transmission line in front of the property that will be used to supply the substation. Therefore, easement acquisition from landowners will not be required. Figure 1 displays an example of a substation. Figures 2 and 3 display an example of a high-voltage transmission line and a lower-voltage distribution line, respectively.
