TWO GENERATION PLANNNING CONTRACTS



CPS Energy will contract with two companies for generation planning support:

- One company will provide modeling & analysis services
- A second company serve as the RAC advisor.
 They will be available to answer any questions the RAC might have as well as conduct a "peer review" of the process; they will not run a separate model



We will be using two firms for generation planning.

One firm to provide modeling & analysis services & the other to be an advisor for the RAC.



Why Charles River Associates?



- They use the same production cost modeling software (Aurora) as CPS Energy
- CRA model outputs will seamlessly synchronize with CPS Energy's cash flow model, allowing financial metric and bill impact analysis by CPS Energy's financial team





We will collaborate with the RAC as well as our community to ensure the modeling firm runs the scenarios that reflect community feedback.

RAC ADVISOR

- The second contractor will be an advisor for the RAC
- The contractor will be chosen by the RAC
- Contractor will sign a Non-Disclosure Agreement that will allow access to information, in compliance with CPS Energy's confidentiality policy
- Their duties will include:
 - Review generation planning inputs, assumptions, process, and results from both CPS Energy and Charles River Associates for reasonableness
 - Attend all the RAC meetings to help answer questions
 - Report to the RAC with a written report and in person at a RAC meeting





The RAC advisor will be chosen by the RAC and will be available to the RAC throughout the process.

RAC ADVISOR SCOPE PAGE 1 OF 2

The scope of the advisor will include:

- Review major CPS Energy and CPS Energy consultant input assumptions associated with key electric market drivers such as load growth forecasts, commodity price forecasts, environmental policy expectations, and ERCOT market outcomes for reasonableness
- Assess CPS Energy's scenario concepts and alternative approaches to risk analysis (this might include extreme event and stochastic analysis) and how they compare with industry standards
- Benchmark input assumptions and uncertainty ranges against public datasets, industry norms, and those used by utilities across the country





RAC ADVISOR SCOPE PAGE 2 OF 2



The scope of the advisor will include (continued):

- Evaluate the various portfolio constructs CPS Energy expects to develop for reasonableness
- Review major portfolio modeling outputs to confirm the relative performance of various portfolios against major CPS Energy objectives and metrics
- Provide technical advisory support to the RAC during its meetings and offer comments to CPS Energy throughout the process
- Provide a report to the RAC related to the tasks specified above.
