Approval of Payment to the City of San Antonio for September 2025

The New Series Bond Ordinance that took effect February 1, 1997 provides for a total cash payment to the City of San Antonio (City) in an amount not to exceed 14% of gross revenue as calculated pursuant to such Ordinance, less the value of other services provided to the City, with the percentage (within the 14% limitation) to be determined by the governing body of the City. The cash transfer to the City for the month of September 2025 is based on actual gross revenue per the New Series Bond Ordinance of \$346,738,219.36, less applicable exclusions. The revenue for the month of September 2025 is calculated as follows:

CPS ENERGY MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES HELD ON SEPTEMBER 29, 2025

The Regular Meeting of the Board of Trustees of CPS Energy for the month of September was held on Monday, September 29, 2025, in the Board Room on the First Floor of the CPS Energy headquarters located at 500 McCullough, San Antonio, Texas.

I. CALL TO ORDER

Chair Romero called the meeting to order at 1:01 p.m.

Present were Board members:

II. SAFETY MESSAGE, INVOCATION AND PLEDGE OF ALLEGIANCE

A safety message, invocation, and the Pledge of Allegiance were delivered by Ms. Angela Rodriguez, Managing Principal, Sustainability & Grants.

III. PUBLIC COMMENT

- Ms. Henrietta LaGrange, community member, stated her appreciation for CPS Energy employees and the Board of Trustees.
- Mr. Alan Montemayor, Chief of the Alamo Group of the Sierra Club, expressed concerns about the recent purchase of natural gas units and climate change.
- Mr. Adrian Shelley, Texas Director of Public Citizen, urged the Board to reinstate the residential solar rebate program.
- Mr. Michael Gilbert, CPS Energy retiree, expressed concerns about changes to the CPS Energy retiree healthcare benefits.
- Ms. Deborah Ponce, Public Citizen, expressed her support for Ms. Diana Lopez as a member of the Community Input Committee.
- Mr. Jason Ponce, Urban 15 Arts Organization, requested the Board of Trustees review billing classes and rates, and assist with solar panels. He also stated his qualifications for an engineer position.
- Ms. Patricia Major, CPS Energy retiree, expressed concerns about changes to the CPS Energy retiree healthcare benefits.

- Mr. Ramon Moreno, IDEA Public Schools, stated he wished to continue the partnership with CPS Energy on energy savings through the Sustainable Tomorrow Energy Plan (STEP).
- Ms. Deborah Henrich, CPS Energy retiree, expressed concerns about changes to the CPS Energy retiree healthcare benefits.
- Ms. DeeDee Belmares, Public Citizen, urged the Board to reinstate the residential solar rebate program with an added rebate for low-to-moderate income customers.
- Ms. Shannon Mills, BLCCS, spoke in favor of STEP and noted the businesses she believes can benefit from the program, including non-profit organizations.
- Mr. Peter Bella, community member, spoke in support of STEP, including the expanded community solar.
- Mr. Ted Slansky, CPS Energy retiree, expressed concerns about changes to the CPS Energy retiree healthcare benefits.
- Ms. Lawson Picasso, Chair, Community Input Committee (CIC), reviewed the positive process the CIC took to amend bylaws, noting the changes were approved 12-1, and she requested Board support.
- Ms. Dianne Lovett, Bandera County, Hill Country Equestrian Line, expressed concern about the potential path of the 765 kV transmission line approved as a part of the state's long-term reliability plan.
- Ms. Amanda Griffin, Hill Country Preservation Commission, expressed concern about the potential path of the 765 kV transmission line approved as a part of the state's long-term reliability plan.

IV. CHAIR'S REMARKS

Chair Romero provided brief comments on the purpose and proper substance of minutes, the healthcare benefits process, the recent acquisition of generation assets, and the Energy 2 Business (E2B) program. She then thanked all applicants for the NE Quadrant Trustee position. Finally, she took a moment to thank Mr. John Kelly for his service to CPS Energy as he concludes his time on the Community Input Committee.

V. CEO RECOGNITION & REMARKS

Mr. Rudy Garza, President & CEO, recognized the second quarter CEO Core Values Award Honorees, noting their contributions to our purpose and mission. He also gave a brief overview of the agenda.

VI. APPROVAL OF CONSENT ITEMS

On a motion by Vice Chair Dr. Mackey, seconded by Mayor Jones, the following items on the Consent Agenda were approved on a 4-1, with Trustee Steen voting against the motion:

A. Approval of Payment to the City of San Antonio for August 2025

The New Series Bond Ordinance that took effect February 1, 1997 provides for a total cash payment to the City of San Antonio (City) in an amount not to exceed 14% of gross revenue as calculated pursuant to such Ordinance, less the value of other services provided to the City, with the percentage (within the 14% limitation) to be determined by the governing body of the City. VII. COMMITTEE REPORTS

In the interest of time, Chair Romero accepted the submission of the following reports for the record in lieu of having them read during the meeting:

Community Input Committee Reports

VIII. PROCUREMENT REQUEST FOR APPROVAL: ELECTRIC PVC CONDUIT

Mr. Richard Medina, Chief Energy Delivery Officer, explained that the procurement is required to encase underground electric cable and wire for substation and distribution systems. Mayor Jones moved to approve the procurement, and it was seconded by Vice Chair Dr. Mackey. The Board of Trustees asked questions about the scope of services, process, and costs. The motion was approved unanimously.

IX. PROCUREMENT REQUEST FOR APPROVAL: MILLWRIGHT MAINTENANCE SERVICES

Mr. Benny Ethridge, Chief Energy Supply Officer, explained the procurement supports necessary millwright services which involves installing, aligning, diagnosing and repairing heavy machinery and mechanical equipment. Vice Chair Dr. Mackey moved to approve the procurement, and it was seconded by Trustee Gonzalez. The Board of Trustees discussed the contracting process. The motion was approved unanimously.

X. FY2026 SECOND QUARTER PERFORMANCE UPDATE

Mr. Cory Kuchinsky, Chief Financial Officer, provided a second quarter performance update. He noted that our financial metrics and fiscal resiliency score are in line with the financial plan. He also reviewed the past due balances for accounts receivables and the results of collection efforts. Ms. Elaina Ball, Chief Strategy Officer, then reviewed the FY2026 Enterprise Scorecard, explaining the on track, at-risk, and unrecoverable measures.

The Board of Trustees discussed the presentation and asked questions. The discussion and questions focused on the recent acquisition of generation assets and related changes to financial metrics and borrowing levels, progress on past due receivables, the level of wholesale revenue, at-risk metrics and related mitigations, support of customers at risk for disconnection, macroeconomic factors, demand side/energy efficiency efforts, and investment choices.

XI. STEP UPDATE: PROGRAM YEAR 3

Mr. Jonathan Tijerina, Vice President, Corporate Development, presented an overview of performance and highlights for the first three years of the Sustainable Tomorrow Energy Plan (STEP). He noted that it is a 5-year, \$350 million plan. He then reviewed the goals and where we are today in demand reduction, the types of current and future programs, and overall customer participation.

The Board of Trustees discussed the presentation and asked questions. The discussion and questions focused on solar rebates, customer participation in City Council Districts 4 and 5, avoided costs from the program, and potential future program and outreach opportunities. Trustee Steen requested that his ongoing objection to STEP be included in the minutes, specifically his concerns about the costs of the program, impact to past-due customers, and preference for this to have been a voting item to consider pausing the program.

XII. ERCOT MOBILE GENERATOR UPDATE

Mr. Richard Medina, Chief Energy Delivery Officer, provided an update on the ERCOT mobile generator project. He explained that this is a temporary mobile generation project which provides ERCOT with options to mitigate the risk of overloading lines until permanent transmission upgrades eliminate constraints. He then provided an overview of our work with ERCOT to facilitate the interconnection of 15 generators to some existing CPS Energy substations.

The Board of Trustees discussed the presentation and asked a question about how the mobile generators may called into service, and Mr. Medina noted there is a small chance of them being used.

XIII. COMMUNITY INPUT COMMITTEE CANDIDATE APPROVAL

Ms. Kathleen Garcia, Vice President, Government and Regulatory Affairs & Public Policy, introduced the three nominees to the Community Input Committee, as follows:

- 1. Diana E. Lopez, District 2
- 2. Lawson Picasso, District 6
- 3. Michael Kennick, District 8

She then requested approval of the recommended nominees. Vice Chair Dr. Mackey made a motion to approve all three candidates, Mayor Jones seconded, and the motion was approved unanimously.

XIV. COMMUNITY INPUT COMMITTEE BYLAWS APPROVAL

Ms. Kathleen Garcia, Vice President, Government and Regulatory Affairs & Public Policy, reviewed the process the Community Input Committee (CIC) took to review the bylaws. She then provided a summary of the proposed revisions and an overview of the next steps. Finally, she requested Board approval of the proposed revisions to the bylaws.

Vice Chair Dr. Mackey moved to approve the bylaws, and Mayor Jones seconded. The Board of Trustees discussed the proposed revisions. Trustee Steen asked Ms. Lawson Picasso, Chair of the CIC to share her thoughts about the process. Ms. Picasso stated it was a robust conversation and that she is very proud of the feedback received and believed the CIC came together for the proposed bylaws. The other questions by the Board of Trustees focused on ensuring diversity in membership, monitoring the level of time commitment for members, and ensuring the CIC operates independently of the Board. The motion to approve the changes to the bylaws was approved unanimously.

XV. EXECUTIVE SESSION

At approximately 4:29 p.m., Chair Romero announced the Board would go into Executive Session, and Ms. Ramirez announced that the required notice had been posted and that the Trustees, with only necessary parties in attendance, would convene into Executive Session, pursuant to the provisions of Chapter 551 of the Texas Government Code, for discussion of a number of posted items, including the following:

The Board reconvened in open session at 5:00 p.m. The quorum was re-established, and all members were present. Ms. Ramirez reported that only the matters cited above, and no others were discussed, and no votes were taken in Executive Session.

XVI. ADJOURNMENT

Chair Romero asked Ms. Ramirez to review the requested action items. There being no further business to come before the Board, upon a motion duly made by Vice Chair Dr. Mackey, seconded by Trustee Steen, and upon an affirmative vote by all members present, the meeting was unanimously adjourned at 5:02 p.m. by Chair Romero.

BACKGROUND:

- CPS Energy staff provides oversight of the activities and performance of the following two NDTs:
 - o 28% CPS Energy NDT (the 28% Trust) and
 - o 12% Texas Central Company (TCC) Funded NDT (the 12% Trust)
- CPS Energy utilizes nine IMs to manage the investment of assets in both the 28% Trust and the 12% Trust. CPS Energy staff, with the assistance of its Investment Consultant, Callan, LLC (Callan), oversees NDT IM performance.
- Our CPS Energy Investment Policy and the Texas Public Funds Investment Act (PFIA) require CPS Energy Board (Board) approval for the initial contract and any related extension of IM Agreements for the 28% Trust and the 12% Trust. IM Agreements, whether initial or an extension, are valid for a period of two years.
 - The IM Agreements were last renewed by the Board in October 2023, effective February 1, 2024.
- The CPS Energy NDT Investment Committee (NDT IC), in conjunction with Callan, has determined that.
 - o IM performance has been acceptable relative to the benchmarks and IM fees are competitive relative to their peers.
 - The following IM Agreements with the eight IMs listed below need only to be renewed (with no updates).

- Replacement of an underperforming IM, with MFS Investment Management (Mutual Fund) in both the 28% and 12% Trusts is warranted, due to strong performance and MFS' complimentary strategy to current international equity IMs.
- We request approval to replace an underperforming IM, with MFS Investment Management (Mutual Fund) for investment in the MFS International Diversification Fund, effective February 1, 2026.
- The proposed change better aligns current international equity strategy with the longterm growth strategy of the Trusts.
- IM Agreements have been reviewed by Cash and Liquidity Management and Legal Services to ensure compliance with CPS Energy policies and guidelines.
- CPS Energy staff will continue to monitor IM performance to ensure satisfactory investment returns relative to their benchmark. In the event CPS Energy would need to terminate an IM in the future, IM Agreements carry termination clauses that allow CPS Energy to terminate the IM Agreement with the required written notice.

NUCLEAR DECOMMISSIONING TRUST INVESTMENT MANAGER AGREEMENTS RESOLUTION

The following resolution relating to the Nuclear Decommissioning Trust activities of the City of San Antonio, acting by and through the City Public Service Board ("CPS Energy") was presented for consideration and approval by the Board of Trustees:

WHEREAS, Texas Government Code Section 1502.070 vests management and control of the CPS Energy gas and electric system in the Board of Trustees of CPS Energy (the "Board"), including management and control over the purchasing activities of the systems; and

WHEREAS, the Board is responsible for the prudent handling and control of funds and investments of the City Public Service Decommissioning Master Trust for the South Texas Project (the "28% NDT"), and the City Public Service Decommissioning Master Trust Agreement Related to the South Texas Project Interest Acquired from AEP Texas Central Company (the "12% NDT"), pursuant to the South Texas Project Nuclear Decommissioning Trust Investment Policy (the "Policy"); and

WHEREAS, Texas Government Code Section 2256.003(b), a section of the Public Funds Investment Act ("PFIA"), requires that the Board of Trustees approve contracts with investment management firms to help implement the Policy and provide CPS Energy with investment advice; and

APPROVING AND AUTHORIZING CONSTRUCTION OF THE HOWARD ROAD 345KV/765KV SWITCHING STATION AND THE ACQUISITION OF FEE SIMPLE TITLE AND PROPERTY EXCHANGES WITH OUTSIDE ENTITIES FOR A PORTION OF THE PROPERTY LOCATED AT THE SOUTH EAST CORNER OF STATE HIGHWAY 16 AND WATSON ROAD/LONE STAR PASS IN SAN ANTONIO, BEXAR COUNTY, TEXAS, EITHER BY PURCHASE THROUGH NEGOTIATIONS OR BY THE PROCESS OF EMINENT DOMAIN, FOR THE CONSTRUCTION, OPERATION, EXPANSION, AND MAINTENANCE OF A 345KV/765KV SWITCHING STATION, ELECTRIC TRANSMISSION LINES, DISTRIBUTION LINES, COMMUNICATION SYSTEMS, AND RELATED APPURTENANCES.

WHEREAS, in 2023 the Texas Legislature (HB 5066) required the Public Utility Commission of Texas (PUC) to develop a reliability plan for the Permian Basin Region. On April 24, 2025, the PUC approved the development of three 765kV import path corridors. The Howard Road to Soltice Project (one of the required three import path corridors) will be jointly developed by CPS Energy and AEP Texas. The construction of the Howard Road 345kV/765kV Switching Station is a critical and essential piece of PUC's Permian Basin Reliability Plan and a key part of the plan to strengthen the entire ERCOT grid (the "Howard Switching Station Project");

WHEREAS, the Howard Switching Station Project has a projected completion date of December 2030;

WHEREAS, the Board agrees with the staff's determination that selected site for the Howard Switching Station is the best option to provide the necessary support PUC's Permian Basin Reliability Plan:

WHEREAS, the Board finds necessary and desirable for the construction of the Howard Switching Station Project and the acquisition of fee simple title and property exchanges with outside entities for the property located at the South East corner of State Highway 16 and Watson Road/Lone Star Pass in San Antonio, Bexar County, Texas for the construction, operation, expansion, and maintenance of the City of San Antonio Electric System, including the construction, operation, expansion, and maintenance of the Howard Switching Station Project, either by purchase through negotiations, or by the process of eminent domain approved by the San Antonio City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY PUBLIC SERVICE BOARD OF TRUSTEES that:

- 1. The recitals to this Resolution are hereby incorporated for all purposes.
- 2. The Board finds that the Howard Switching Station Project is of great importance and necessary to the public and for the public use, and that CPS Energy has taken into account appropriate considerations in choosing and designating the recommended site.
- 3. The Board hereby approves the CPS Energy Howard Switching Station Project to be constructed on the recommended site as generally depicted on the Project Site Map attached to this Resolution as Exhibit "A" and hereby incorporated for all purposes and directs CPS Energy staff and attorneys to proceed with the necessary steps to undertake and complete the Howard Switching Station Project.
- 4. The Board authorizes the President and CEO of CPS Energy and/or his designee to take the necessary steps to complete the Howard Switching Station Project on the site as depicted generally on Exhibit A. The Board also authorizes the President and CEO of CPS Energy and/or his designee to make reasonable

modifications to the size, configuration, and location of the Howard Switching Station Project, as deemed necessary.

5. The Board finds that the acquisition of easement rights, fee simple title to properties, and property exchanges with outside entities at the recommended site is necessary for the important public purpose and use of the construction, operation, expansion and maintenance of the City of San Antonio's Electric System, including the Howard Switching Station Project. The Board hereby authorizes acquisition of easement rights, fee simple title, and property exchanges with outside entities necessary for CPS Energy's Howard Switching Station Project, either by purchase through negotiations or by the process of eminent domain, as well as all other lawful action necessary and incidental to such acquisitions or eminent domain proceedings to survey, specify, define, and secure the necessary title and rights.

Community Input Committee (CIC) Committee Report

The Community Input Committee met on October 8, 2025. Due to technical difficulties with the recording, the first 45 minutes of this meeting were not captured. The summary below is reflective of the discussion. As part of the agenda, the committee:

- A. Received a presentation on CPS Energy's recent acquisition of natural gas peaking power plants in Brazoria, Harris, and Galveston counties, totaling 1,632 MW. These assets, which are relatively new and could operate for 40 years, are now being integrated into CPS Energy's generation fleet, supporting the existing Board-approved Generation Plan. The acquisition enhances grid reliability, helps meet peak demand, and provides long-term bill savings when compared to the higher costs of constructing new facilities. The acquired plants also offer future flexibility, with dual-fuel capability allowing for a potential transition to a hydrogen fuel blend.
- B. Received a presentation on CPS Energy's efforts to refresh its Generation Plan that will guide how the utility powers San Antonio and the surrounding region into the future. Building on the foundation of the Vision 2027 Plan, the Generation Plan update seeks to preserve a balanced and diversified energy portfolio that balances reliability, affordability, and environmental responsibility. With San Antonio being one of the fastest-growing cities in the country, this effort is designed to address new planning assumptions such as rapid community growth, emerging technologies, and evolving regulatory landscapes. The updates to the plan will continue to incorporate insights gained from extensive community engagement including input from the Citizens' Input Committee (CIC), ensuring that customers, stakeholders, and partners help shape the utility's long-term strategy. The Generation Plan update will also evaluate the needs of large-load customers, explore emerging and advanced technologies, and consider changes in federal and state energy policy. Additionally, it will reassess current operations and identify new opportunities, such as leveraging recent acquisitions and market efficiencies, to strengthen system reliability and maintain affordability for customers. It is anticipated that the CIC will receive another update at their December meeting, including preliminary results of the ongoing portfolio analysis conducted by Charles River Associates.

The next CIC meeting is scheduled for December 10, 2025.

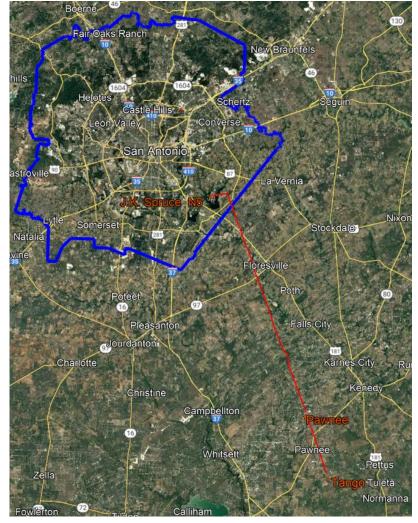

- Rebuild an existing 58-mile long 345kV transmission line from the Spruce Power Plant to the Pawnee Station to the Tango Station in South Texas.
- The transmission line will be reconstructed from a single circuit to a double circuit while it remains energized due to the line being deemed a reliability risk.
- Additional funding is required due to expanded scope in final design, larger/more numerous structures, increased ROW/access needs, and complex lake crossing.
